Notice to Consignors

- Location:** Lone Star Park, Grand Prairie, Texas. Take I-30 between Dallas and Fort Worth. Take Exit 34 onto Beltline Rd. Go North to Lone Star Parkway (1/4 mile), take a right. Go to Pollock Place, take right and follow road around to the left to Stable Gate.
- Date/Time:** August 25, 2026 at 11:00 AM
- Stabling:** Stabling will be available to consignors at Lone Star Park on August 21, 2026.
- Prohibited:
Practices** *The following practices are not permitted on the sales ground*
♦ **Extracorporeal Shock Wave Therapy/Radial Pulse Wave Therapy**
♦ **Acupuncture/Electric Stimulation with the intent of altering Laryngeal Function.**
♦ **Any invasive practice which intentionally conceals a material defect or lameness.**
♦ **Internal blisters or other injections to the knee intended to have the effect of concealing the true conformation of the horse are not permitted.**

- Registration** We request that all Digital Jockey Club Certificates be transferred as soon as possible. All certificates are required in our office by **August 3, 2026**.
- Health Certificates:** All horses traveling to the sale must be accompanied by a Health Certificate dated within **10 days** of the sale that **includes EHV1** vaccination information.
- E.I.A. (Coggins):** Each horse in the sale must have an individual negative Coggins Certificate dated within six (6) months of the sale, no earlier than **February 25, 2026**. **All Coggins or copies of Coggins are due by August 3, 2025. Please e-mail to: raineybb817@gmail.com**
- A charge of \$50.00 will be deducted from proceeds for any Coggins drawn on the sale grounds**
- EHV-1:** It is required that all horses are vaccinated for **EQUINE HERPES VIRUS**. Proof of a FDA approved **EHV-1** vaccine or **EHV-1** booster, within 90 days of August 25, 2026 **must appear on Health Certificates**.

- Stable Equipment:** There will be no stable equipment supplied. All screens, tubs, buckets, Rakes, forks, tack, etc. must be brought by the consignor. **Consignors are reminded that the stalls at Lone Star Park do not have doors and consignors need to bring or have already made arrangements for a form of closure for the stall.**
- Stall Cards:** **TTA DOES NOT SUPPLY STALL CARDS.** If you order a stall card from Barbara Twaddle (see flyer) fees will be deducted from proceeds. Deadline for placing orders August 10.
- Bedding:** Stalls will initially be supplied with straw. If you prefer to bed on shavings, please make your own arrangements. (Contact for the feed company, Master Made, has been provided on a separate page.)
- Stall Alterations:** Any stall alterations must be done by Lone Star Park personnel.
- Halters:** All horses are to be sold with leather halters. The consignor will be charged **\$45** for a leather halter for any "sold" horse left on the sale grounds without one.
- Rooms on Track:** Rooms in the stable area may be reserved for stable help (see Request form). **No beds or bedding will be provided.** Consignors will be charged **\$25** for any dorm room keys not returned.
- Repository:** All information that consignors wish to have in the repository should be submitted before **8:00 AM Saturday August 24, 2026**
- Responsibilities:** **Consignors are responsible for their horses up to 24 hours after the fall of the hammer. If their horse has not been picked up by the time the consignor is ready to leave they should notify the stable office to ensure the care of the horse.**

2026 YEARLING SALE**

1. All **IMAGES MUST BE TAKEN WITHIN 30 DAYS OF SALE** and submitted in DICOM 3.0 Format may be uploaded direct to ASTERIS, emailed, submitted on a USB thumb drive or CD drive.
2. All images per hip must be in a single DICOM folder.
3. All images are due by 8:00am – August 24, 2026
4. DICOM tag requirements:

PATIENT ID = TTAYRLG25-HipXXX

TTA = Texas Thoroughbred Sales

YRLG = Yearling Sale

26 = 2026

XXX = Full Hip Number, including leading zeroes i.e. 001

Example: TTAYRLG26-Hip119 or Hip001

PATIENT NAME = Dam Name

Example: Taylor's Playmate 21

STUDY DESCRIPTION = Name of Veterinarian taking radiographs

STUDY DATE = Date of radiographs

5. Letters and certificates accompanying a hip must be delivered to Texas Thoroughbred Sales at the time the radiographs are submitted.
6. To accommodate viewing sort order all hips must be submitted with the anatomical/view info on Page 2 – To set this up you may have to contact your equipment representative.
7. When downloading x-rays to a hard drive/USB drive or CD each set must be in its own folder and labeled as follows – Hip116 – No zeroes or spaces between hip and the number, with the word “hip” in small case. 8. In effort to encourage more use of the repository pre-sale and more accurate veterinarian information for use on the sales grounds, all x-rays submitted to the repository must be accompanied by a veterinarian x-ray report. This report will be acknowledged as having been received by the sales company and the stamped report will be returned to the consignor. A copy will be kept on file in the repository as well. The x-ray report must also disclose attending veterinarian's ownership interest in the subject horse, if any. (see attached)
